1 Overall

1.1 Revenue and Expense

IMPACT Growth Real Estate Investment Trust (IMPACT GROWTH REIT) earns Bt. 568.253, from September 22-December 31 2014, which is from Bt. 565.51 million service incomes Bt.1.4 million Interest income and Bt. 1.7 million for other income, totally brings Bt. 348 million net profit. However, Bt. 565.51 million service incomes can be divided into 84% venue sale, secondly 7% from F&B right fee and media space rental and 6% for long term rental space and service. The most contributed assets are IMPACT Challenger and IMPACT International Exhibition Center. IMPACT GROWTH REIT's expense comes from cost of service at Bt.78.3 million, mainly in 51% utilities and 25% service. All the same for fees which can be considered at 11% from total revenue (Bt.61.6 million) are Bt. 31.7 million REIT Manager fee, Bt. 16.7 million Trustee's fee, Bt. 1 million Registrar's fee, Bt.11.37 million Property Management fee and Professional fees at 815,000 baht led to Bt.346.251 million REIT's net profit and Bt. 1.842 million on net unrealized gains on investments. As a result, REIT's net asset is up to Bt.348.093 million with 86% Gross Profit Margin and 61% in Net Investment Income Margin.





1.2 Balance Sheet

At the end of December, the REIT reported investments in properties in fair value of Bt. 19,603 million and net assets of Bt.16,062.593 million, or Bt. 10.8348 net asset value per unit which is increased from Bt. 10.6005 at September 30, In this period, the REIT reported investments in properties in fair value of Bt. 19,603 million which increased from at the end of September in which reported investments in properties in fair value of Bt. 19,601.156 million, or increased by Bt. 1.842 million, Furthermore the REIT reported investments in securities (Fixed Income Fund), at the end of December, the REIT reported fair value of the securities of Bt. 349.998 million.

2 Net Investment Income & Distribution

The REIT reported the third quarter of 2014 Net investment income of Bt. 346.251 million and announced the distribution of Baht 0.23 per unit. The XD Date was February 24, 2015, The record date for entitlements to the interim dividend was 26 February 2015, the book closure date for collecting shareholders' name is accordance with Section 225 of Securities and Exchange Act was February 27, 2015 and the payment Date was March 13, 2015.


